SUBJECT: Publication of DoD Competition Reporting – 3rd Quarter FY 2014

At the August 4, 2014, Business Senior Integration Group (BSIG) meeting, the Under Secretary of Defense for Acquisition, Technology and Logistics announced that he plans to address competition as a recurring BSIG agenda item. To facilitate preparation for those meetings and increase visibility and accountability for results, we will publish competition data on a quarterly basis to keep you apprised of your organization's contribution and progress toward DoD's FY 14 competition goal of 58%.

The attached spreadsheets identify the competition metrics as of July 31, 2014. The metrics are based on the competition report which tracks obligation and actions based on data from the Federal Procurement Data System - Next Generation (FPDS-NG).
